19.088 - PLANNING APPLICATIONS

(a) The Councillors considered the planning applications as listed below: -

Details of Planning Application	Comments
Ref: 19/00969/FUL – Two-storey and single-storey rear extensions (amended scheme) at Dexter House, The Fold.	The Parish Council does not object but wishes to make sure that the neighbours are not adversely affected by the proposed extensions.
Ref: 19/01194/FUL – Single-storey rear extension, single-storey side extension to house oil tank, 1no. roof light to rear and erection of detached store to rear at Alder House, 4 Laburnum Farm Close.	The Parish Council does not object but has the following concerns: 1. The proposed location of the oil tank and its proximity to the house and neighbouring property. 2. The proposed location of the new shed may extend the built form of the village and impact on the Green Belt.
