### MINUTES OF THE PARISH COUNCIL MEETING HELD AT 8.00PM IN THE CHAPEL SCHOOLROOM, HESSAY, ON WEDNESDAY 12 MAY 2010

#### **10.035 - ELECTION OF CHAIRMAN**

Councillor Booth was proposed and seconded and unanimously elected as chairman.

#### **10.036 - TO RECEIVE THE CHAIRMAN'S SIGNED DECLARATION OF ACCEPTANCE OF OFFICE**

Councillor Booth signed the Declaration.

Councillor Hildreth was proposed and seconded and unanimously elected as vice-chairman.

**10.043- TO DISCUSS THE REPLACEMENT OF THE HEDGE IN THE CHILDREN'S PLAY AREA**

It was agreed that the hawthorn hedge that had been removed from the children's play area should be replaced by a hedge that had no thorns. The City Council is to be asked to make the arrangements. **(Action Clerk)**

The subject of a Parish Council website was discussed at the preceding Annual Parish Meeting. It was agreed that a dedicated website would be better than a group on Facebook. No resolution was made.

**10.048 - TO DISCUSS ROAD AND PATH SWEEPING AND POTHOLES**

It was noted that the City Council road sweeper had recently been through the village but with the weather having been so dry it had made little impression on the rubbish in the gutters. It was agreed that the City Council be made aware of this and that it be asked to remedy the situation. **(Action Clerk)**

It was noted that there has been an improvement in the state of the potholes.
